Advice for INTERNATIONAL students on a Tier 4 visa only:

Withdrawals will be reported to UKVI as 'withdrawal of sponsorship'. This means that your current visa will be curtailed (cancelled) and you will need to leave the UK.

To return to your studies or research in the future you will need a new CAS in order to apply for a new Tier 4 visa to enter the UK.

Before your withdrawal application can be approved, you **must** discuss your visa with the International Advice & Guidance Team.
